TREASURER'S REPORT



I here by tabled the Financial Statements of Walker Close and Brooklyn Hall Asso. Inc. for the financial year 2021-22.

The Centre income comprises three sources: operational grant from Hobsons Bay City Council,
Neighbourhood House Coordination grant from Department of Families, Fairness and Housing and from internal selfgenerated income as shown below.

Total income for the year \$26,247 compared to last year has shown an increase of 38% even though continue working with COVID-19 disruption we managed to survive well.

The balance sheet shows total net asset \$306,924 with a contingent reserve cash balance \$101,715 to cover unforeseen of costs, and employee entitlements.


The major expenditure mainly includes power usage, salary and wages, promotion, janitorial services, telephone make up approximately 75% of the total expenditure. The full set of accounts are displayed under Appendix A (financial statements contained within the audit report) of this annual report.

I remain confident Walker Close will keep its financial viability in a stronger position.

With this opportunity, I would like to thank Ayelign Tessema, centre manager. His professional advice has been great value, without his work the centre finance wouldn't have been strong and to me my job as a treasurer would have been very difficult.

I would also like to thank all members of the Committee of Management for their valuable input, and I have a strong belief that Walker Close will keep continue to deliver its valuable programs and services to the community in the years ahead.

BROOKLYN COMMUNITY HALL DEVELOPMENT

The council's commitment to the improvement of the Brooklyn Reserve, open space, playground, and foot paths has enhanced the quality of community services delivery at Brooklyn community hall. Lots of interests have been raised. While also appreciating council's effort for improving the hall with additional rooms to flexibly run programs and activities.

The new outside facilities have created great opportunity for the community to come together with a sense of belonging inclusiveness.

The groups who have been using the hall are eagerly waiting for the completion of this development which was supposed to be completed by the middle of 2021, but due to additional ideas and changes, it is still in progress within this reporting period. This has created frustration between various community group especially who have been utilising the venue for an extensive number of years.



What is important to be done?

As a community advocate working closely with the community, having lots of experience about the community in the area and in knowing how the hall been used in the past, there is a significant need for additional car park sites which has been identified. We have been advocating this to happen and have put forward our concerns at various steering committee meetings.

It is absolutely, great developing the facility with additional rooms that can accommodate and to flexibly run various programs and activities simultaneously. One crucially needed is additional car park. From our experience let alone with additional rooms added and more users coming. The existing car park was not enough for the previous users that all impacted to the residents living around the hall. Their driveways were blocked by the outside users of the hall, and it is not hard to imagine what will happen when more users are coming through.

We presume the facility not to be like a resort or a quite silent retirement village but rather to be a vibrant actively used community facility. So, to enhance its suitability in both ways, additional car parking is crucial which will also be a great relief for the surrounding residents.

Hence, we strongly recommend that the Council addresses this need upon completion of the redevelopment plan. Input from residents and users in the vicinity of this hall should be obtained through consultation to ensure as many stakeholders as possible, are given the opportunity to express any additional needs which may arise throughout the time of the redevelopment.

Manager's report



It has been another interesting year. Fortunately, we have been relatively unscathed this year with only a short lockdown required. The centre stayed open during this period, ensuring that those in our community who need support were able to make ends meet.

We are proud to have implemented our various projects that included a two-phase stay connected project under the Make It Happen grant funding from Hobsons Bay City Council which have benefited our community enormously with getting connected, socialising, and maintaining their health and well-being in response to the impact of COVID-19 which created lots of issues between the community.

These projects have advanced the lifelong learning through art and craft (Craft & Cuppa classes) and a fitness exercises selectively for women (Femm Fitness classes) which involved a diverse community group and created lots of fun and joy whilst sharing their experience and skills.

Through these activities, we were able to:

- Increase knowledge and understanding of the cultural diversity of our community values
- Create stronger community bonds within the subgroups of our wider community by expanding individual and group connections
- Increase awareness of the activities and services available to the community
- Re-engage cultural/ethnically diverse groups to participate in the life of the community

We are lucky to have many people with ideas and energy for things to happen. All they need was some support from us to make it happen.

Thank you to our team of staff and volunteers for your dedication. A special thanks to Rebecca Bogale, Adiam Beyin and Grace Corcoran for effectively implementing our stay connected community projects from the program design, survey, and final implementations of fitness for women, and art and craft projects with excellent achievements as expounded over the pages. It is a privilege to work alongside such a fantastic team who generously gave their time and passionately contributed to our community.

I would also, would like to thank our Committee of Management for their commitment to the Centre and the support they provide to me in my role for working closely being available and sparing their extra time whenever needed.

I warmly acknowledge our partners' collaboration with us which helped us to provide meaningful and needed programs/activities throughout the year. A special thank you to Sandy Joffe Network West for her unreserved support connecting us with other service providers.

ENGAGING COMMUNITY


The services we offer vary according to the specific needs of the many subgroups which make up our local community. Hence, we recognise the importance of creating opportunities for all groups to come together and share their experiences and cultures. We believe this encourages different groups to become familiar with the diversity of their Neighbourhood so that networks can be broadened, and new connections can be made. Through these opportunities, we also seek to acknowledge the support and positive contributions people have made towards the community and local organisations, which has been and continues to be vital to the longevity of the Centre.

Diversity Week Celebration

As part of our shared community engagement programs with the Council, the impact of COVID-19 had left our community feeling lonely and isolated. To bring the community back together again, we organised a community get-together event in March during



diversity week on the Harmony Day. We welcomed a large community group coming together to have fun and get connected. The event was celebrated with a traditional coffee ceremony accompanied by a story of Coffee, the Egg, and the Carrot.









OUR COMMUNITY DEVELOPMENT PROJECTS

Stay connected project

This project was designed to enhance social networks and community cohesion through social programs and activities which is essential for community health and well-being to improve knowledge and awareness of mental health issues and to re-frame perceptions of well-being and resilience. We developed two projects with funding from Hobsons Bay City Council under the Make it Happen – Hobsons Bay Recovery and Reconnection Grant. With this funding support we run two successful projects which have added great value to the community.

The **Fem Fitness Classes** created and opportunity for women in the local community and surrounding areas to access a safe and comfortable environment to exercise with others. **The Craft and & Cuppa Classes** created an environment where like-minded people could express their love for crafts together and share their skills with the local community.

The feedback from participants of both projects demonstrated that the overall projects met their objectives to provide a safe, friendly environment for those who had disengaged in the community and were looking to establish new connections withing the local area through social inclusion, social networks and participation in health-based activities.

Fem Fitness Classes



Aims of activity:

- Promote health, wellbeing, reconnection, and the strengthening of the local community
- Facilitate social inclusion and participation from diverse communities.
- Assist the community to recover from the isolation of COVID-19 restrictions
- Provide opportunities for physical activity which have been limited during COVID-19 restrictions

Objectives of activity:

- To provide a safe, friendly environment for those disengaged in the community to establish new connections within the local area through social inclusion
- To support participation in health-based activities for those impacted by COVID-19
- To enhance social networks and community cohesion within the local community



Were the objectives met or not and why?

Overall, the objectives were met as participants reported their satisfaction with the classes. The classes created an opportunity for women in the local community and surrounding areas to access a safe and comfortable environment to exercise with others

Feedback, thoughts, impressions from attendees on the day:

Participants reported that over all they enjoyed the class and were wanting to know if the program would get extended to run more sessions in the future. One participant found the class to be slightly intense for beginner level. Some local participants did not know about Walker Close Community Centre and the activities run at the centre

Participants were initially shy at the beginning of the class but once it began and everyone started participating, the group became more comfortable with each other. Those who attended multiple sessions also became familiar with the class instructor. However, participants began to reduce in the later classes due to colder and rainier weather.

Craft and Cuppa Classes



Aims of Activity:

- Promote health, well-being, and reconnection.
- Facilitate social inclusion and participation from diverse communities.
- Contribute to the strengthening of local communities.
- Assist the community to recover from the COVID-19 environment





Objectives of activity:

- To enhance social networks and community cohesion through a craft group.
- To provide a haven for communication for those disengaged within the community.
- Facilitate social inclusion/participation, essential for community health and wellbeing.
- To support participation and health in those impacted by COVID-19.





Were the objectives met or not and why...

The program met the main objectives of the craft and cuppa sessions, which was to strengthen social networks severed due to COVID-19 and rebuild community engagement. Through our feedback surveys, attendants reported that what attracted them to the activity and had them coming back each week was the social aspect; it allowed them to meet likeminded people and created an environment where they could express

their love for crafts and share their skills. One participant said she usually works on her craft alone in her house, but Craft and Cuppa sessions motivated her to leave her home and interact with the community while learning something new.

Our survey







Feedback, thoughts, impressions from attendees on the day:

We had fantastic feedback from participants. In addition to working on their crafts each week, they could also participate in group activities organised by the project officer, sometimes with the help of participants of Craft and Cuppa who wanted to share their skills with the group. Some participants expressed that they loved having a space that motivated them to socialise and work on improving their craft and wished the program ran for a more extended period and longer session times.







Comments / thoughts on promotion of event / activity:

We mainly relied on the promotion via social media, flyers displayed at Walker Close Community Centre, sending out email invites, and word of mouth. However, attendance really grew when we contacted social groups in the area like Sloan House which included Craft and Cuppa sessions in their programs for senior citizens.

The overall outcomes were fantastic and encouraging.







Partnerships and Networks

Collaboration and partnership remain a priority and relationships with formal and informal partners continue to be productive. Such strong connections enable continuous conversations around community needs, opportunity for creative responses and enhanced organisational profile. Our community service is linked with various community groups. Several of these groups are displayed below.

Though each one of us are different, and no matter how strong individually we are, we believe it is much better when community services are delivered jointly. This inclusive approach creates more opportunities for individuals and groups to enrich their lives through connections they might not otherwise make. The following is a key event which highlighted our local community's cultural diversity this year.

Congolese Fashion Show



The main goal of this Multicultural Fashion Parade is to support and advise culturally diverse and linguistically challenged women, especially when feeling domestic violence. Such an event will bring together members of many communities to collaborate with the Congolese women and encourage their participation.

It is not just a Fashion Show but a representation of Art with Heart and the Freedom of Expression

for a better future to be enjoyed individually as well as collectively. In this event different community group participated that included women form Indian, Ethiopian, Congo, Ghana etc. The event was decorated in African dresses. The attended audience were the western suburbs from across Victoria were welcomed and warmly joined with Ho Mellissa Horne (MP).









VOLUNTEERING

The centre relies on the work of volunteers to provide the services we offer. Hence, volunteering remains at the heart of Walker Close and we aim to continually provide opportunities for people to learn, grow and give back to the community by getting involved in volunteer positions at the centre. In 2021-22 the volunteers at Walker Close contributed an average of 125 hours per month of their time. The centre is highly appreciative of the time, effort and valuable skills offered by these volunteers.

We also thank Bilijana Joveska for managing the centre's reception office every Monday and Thursday. You have been a great help with receiving phone calls, answering various community enquiries and updating weekly group attendance rates for our programs and services.

Notably, our board members are also totally committed to the centre by devoting their time to represent the community needs and cooperatively support the staff and other volunteers. We are very thankful to all committee members.

There are a lot of opportunities to serve the community. So please, if you haven't already, pop in to visit us and see how you can get involved to help us achieve our goals for the Altona North and Brooklyn neighbourhood area, as well as the Hobsons Bay Community as a whole.

OUR COMMUNITY DEVELOPMENT FOCUS

To support the council's social development plan, the centre provides a range of services and programs for people of all ages and backgrounds, applying **the eight dimensions of community wellness**. (ref.BU: Centre for Psychiatric Rehabilitation).





This includes health and wellbeing programs, community-based social activities, educational and recreational programs, information sessions and service referrals. In providing such services and programs, we seek to foster a welcoming and supportive environment to inform the council on how to respond to the needs of our community.

These needs are associated with ensuring equitable access of facilities and resources, sustainable community involvement, respect for diversity, establishment of partnerships with neighbouring service providers and meaningful collaboration through joint initiatives.

These needs are regularly assessed through data collected via surveys, interviews, and key community informants. We also utilise this data to assess the effectiveness of our existing programs and to inform necessary changes in areas of improvement as well as the development of new programs provided to the community, in line with the council's social planning priority areas.

Building community connection is vital and the centre recognise this by providing opportunities for people to actively participate in community activities through various activities. One of famously known and used by the community which became a referral program is fitness-based exercises. Sunday church group that features diverse community groups to support their emotional, spiritual, social wellness to remain connected with in the community to avoid loneliness further to create a sense of belonging with in the community.

WALKER CLOSE AND BROOKLYN HALL ASSOCIATION Serving the Hobsons Bay Community





This program is run by a qualified fitness instructor specifically designed to improve the fitness and wellbeing of people over 50's with disabilities.

The significant positive impact that this program has had on the participants has not gone unnoticed with many reporting that the program has created a sense of inclusion whereby they have been able to build friendships, increase mobility and improve overall wellbeing. This feedback has generated greater community interest in the possibility of running similar programs in the future.

We would like to extend our thanks to Melissa Moorfoot for her professional service to effectively run this program by creating great motivation and enthusiasm amongst the group. With the



increased number of participants and higher interest, the program is now running two days a week on Mondays and Wednesdays between 1:30pm to 2:30pm. Anyone interested is welcome to join.

This program has been running continuously for over several years and is now famously known amongst the local community. It is very pleasing to see it became a referral point for the Health and Wellbeing program.

Programs & Activities

Walker Close Community Centre is a place where people get connected, find information and resources, come together in activities and events, and learn/share the diverse experience and cultures which create this strong community.

During this reporting period, there have been several structured and unstructured and casual programs and functions such as workshops, training, family gathering, social events and other celebrations run.









Parenting group

This program helps new mum to come together and share their first parenting experience and to create an opportunity to socialise and establish friendship and connection.

RECYCLING IN THE LOCAL COMMUNITY

Aims to enhance community understanding of environmental issues through promotion of recycling, freecycles, and Teracycle via flyer sent to local community with Walker Close Term program. We also produced a "A Hobsons Bay Community Recycling Guide" with help from Transition Hobsons Bay

- As part of a standing project, Walker Close has become a public collection point for Teracycle. Becoming a public location is a great way as we will be eligible to collect Teracycle Points for each item dropped off. Community can drop off used oral care cleaning products, Batteries, Phone apparatus, Light globs, Cords & small e-west appliance X-Rays/DVDS/CD's Eyeglasses.
- This included new recycling bins and posters to help people to recycle

Appendix B – Statements of significant accounting procedures

This financial report is special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act. 2012 (Vic). The Committee has determined that the Association is not a reporting entity. The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuation of non-current assets.

The following significant accounting policies, which

are consistent with the previous period unless otherwise stated, have been adopted in preparation of this financial report.

a) Cash and cash Equivalents

Cash and cash equivalents included cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of there months or less.

b) Income Tax

The Association is exempt from paying income tax by virtue of Section 50-45 of the income tax Assessment Act. 1997. Accordingly, tax effect accounting has not been adopted.

c) Property, Plant and Equipment

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation. The depreciable amount of all property, plant and equipment is depreciated over the useful lives



of the assets of the association commencing from the time the asset is held ready for use. Leasehold Improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

d) Employee Entitlements

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period-Employee benefits have been measured at the amounts expected to be paid when the liability is settled. Provision is made for the Association's liability for long service leave from commencement of employment.

e) Provision

specific projects and events is not brought to account as revenue in the current year but deferred as a liability in financial statement until spent for the purpose received.

Capital Grants

Grant income received relating to the purchase of capital items is shown as Unamortized Capital Grant and brought to account

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result, and that outflow can be

reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

f) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is an indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, I compared to the asset's carrying amount. Any excess of the asset carrying value over its recoverable amount is recognised in the income and expenditure statement.

g) Revenue

Revenue is brought to account when received and to the extent that relate to the subsequent period it is disclosed as a liability.

h) Grant Income

Grant income received, other than for specific purpose, is brought to account over the period to which the grant relates.

g) Deferred Income

Unspent grant income received in relation to assets in proportion to the related depreciation charge.

i) Interest Revenue

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

Donations

Donation income is recognised when the entity obtains control over the funds which is generally at the time of receipt.

All revenue is stated net of the amount of good and services tax (GST).
